# Accelerating Women's Empowerment (AWE)

The AWE program improves the economic and social well-being of vulnerable people by supporting skill development for public and private sector organizations. Currently running in 21 countries, AWE provides coaching and mentoring to strengthen small- and medium-sized businesses and local economic development, while advancing gender equality. With the help of Canadian volunteers, we completed nearly 400 assignments across several key sectors, including Agribusiness, Tourism & Hospitality, Nutrition & Health, and Agroforestry.

Most notably, the program's impact extends beyond its direct beneficiaries to improve the quality of life for families, communities, and local partner organizations. We estimate that more than 91,000 people benefited, directly and indirectly, from our approach to inclusive economic development in the past year alone.

#### **AWE Innovation Fund**

By disbursing more than CAD \$222,000 through the AWE Innovation Microfund, we have enabled 64 partner organizations to procure equipment and supplies to implement initiatives that expand women's access to and control over resources and improve their quality of life.

#### **Example of Success: Havila Resort**

Following training provided by Catalyste+ on effective fish farming and aquaculture management, women and youth group members at Havila Resort in Kenya constructed three earthen ponds for tilapia and one ornamental fish pond, boosting fish production by approximately 50%. The training led to the formation of an aggregation group of 11 youth farmers, enabling them to access larger fish markets. This collaboration supported the introduction of new menu items at the resort—including fish fingers, fish sausages, fish samosas, and fresh fish for the buffet—all sourced from the group. The value-added fish products attracted more customers, resulting in a 30% increase in patronage driven by the expanded menu and the appeal of locally produced offerings.

# Indigenous and Northern Services (INS)

Combining 8 programs under the INS banner, we work with Indigenous governments, Micro, Small and Medium-sized Enterprises (MSMEs), nonprofits, and economic development groups across Canada. We prioritize Indigenous knowledge and self-determined goals to support sustainable development through coaching and mentorship in areas such as, strategic planning, human resources, financial management, governance, and business development. In keeping with our innovative spirit, we provide an agile service offering that's tailored to the unique needs of every client's ambitions and context.

The majority of our work has focused on strengthening skills in governance, economic development, and finance. This past year, our assignments directly benefited approximately 2,400 people in more than 600 communities nationwide. These projects combine to support the over–arching vision of Indigenous self-determination and economic reconciliation.

#### Client Highlight: Haley's Handicrafts

Since 2019, Alakan White has been building her business, Haley's Handicrafts, with passion and dedication. Wanting to ensure its long-term sustainability, she worked with Catalyste+ Advisor Tracey Johnston-Aldworth to strengthen her business foundation.

Together, they developed a solid business plan and explored the essentials of running and operating a small business. During this time, Alakan was also working on her website, which now allows customers to book sessions, access tutorials, and purchase her handcrafted art.



## Client Highlight: Whitecourt Isga Tourism Association (WITA)

The Whitecourt Isga Tourism Association (WITA) is a nonprofit organization in Alberta, Canada, that offers Indigenous cultural awareness experiences. Led by Bear Mustus, WITA aims to bridge cross-cultural gaps between First Nations communities and local municipalities by revitalizing Indigenous community spirit.

After receiving mentorship from Catalyste+ on its grant application to the Alberta Aboriginal Business Investment Fund, WITA strengthened its capacity to develop successful project proposals and secure funding. More importantly, it secured \$660,000 CAD to purchase necessary equipment for business expansion.

# Canadian-CARICOM Expert Deployment Mechanism (CCEDM)

The CCEDM program strengthens public sector capacities to design and implement policies and programs to drive sustainable economic growth and diversification. We provide technical assistance to government ministries, agencies, and similar organizations in 9 Caribbean countries. CCEDM is responsive to local development needs and supports key areas of governance, including strategic planning, results-based management, finance, and human resources. Because of the program's unique, demand-driven model, our service offerings are tailored to meet the localized needs and contexts to support sustainable economic development.

In the past year, nearly 1,700 government officials from 38 institutions benefited from our training and mentoring services. Over the past 4 years, we estimate CCEDM has impacted the lives of over 715,000 people across the Caribbean who benefit from improved access to equitable polices, public goods and services, and a stronger regional economy.

### Innovation in the Caribbean

Since the beginning of CCEDM, 25 government organizations have reported innovation in policies, regulations, norms, and practices, including innovations that advance economic growth, are environmentally sensitive, and respond to the needs of women and other vulnerable and marginalized groups.

### **Example of Success: Gilbert Agricultural and Rural Development Center (GARD Center)**

In Antigua and Barbuda, Catalyste+ Advisors supported the Gilbert Agricultural and Rural Development Center (GARD Center) in strengthening its five-year plan and developing a business strategy for farm production. Working closely with the Ministry of Health, Wellness, and Environment, the initiative enhanced staff capacity to gather stakeholder input, analyze crop profitability, and design a high-ROI cropping plan. The resulting business plan positioned GARD to secure support for climate-smart agriculture and expand training programs for vulnerable youth and local communities—advancing sustainable farming and economic development.


### **Financial Statements**
