New funding opportunities

[Creating, Knowing and Sharing: The Arts and Cultures of First Nations, Inuit and Métis Peoples program](#) – Short-Term Projects: It funds First Nations, Inuit and Métis professional and emerging artists, cultural carriers, arts and cultural professionals, groups, collectives and organizations working in all disciplines. Grants provide support for any combination of eligible Creating, Knowing and Sharing activities for projects lasting up to 1 year. This program supports activities in 3 broad areas: creating provides support for research and the production and creation of new works of art; knowing provides support for the retention, maintenance, innovation and transmittal of cultural knowledge and creative practice. This includes contemporary and historical critical discourse, arts/cultural training and initiatives that seek to pass cultural knowledge to younger generations through artistic practice, and the renewal and maintenance of customary art practices; and sharing provides support for the dissemination, exhibition, presentation and distribution of works of art by First Nations, Inuit and Métis peoples, which enrich and engage communities in Canada and abroad.

- **Application Deadline:** July 22, 2026 and November 4, 2026 by 11:59 PM EDT
- **Amount:** Up to \$100,000 and up to \$50,000 for applicants with an Emerging Artist profile
- **Region:** National

[Environmental Damages Fund – Climate Action and Awareness Fund](#): This funding opportunity is offered as Stream 3 of Environmental and Climate Change Canada's Environmental Science Opportunity for research and analysis projects to support Canada's path to net zero. The Climate Action and Awareness fund has three main priorities: support youth climate awareness (summer 2020) and community-based climate action (fall 2020; winter 2022); support climate research at Canadian think tanks and in academia (summer 2022); and advancing climate change science and technology (spring 2021).

- **Amount:** Between \$500,000 and \$2 million over a maximum of 5 years

[Indigenous and Stakeholder Capacity Fund – Indigenous Capacity Support](#): The Indigenous Capacity Support stream funds long-term activities to increase capacity of Indigenous Nations and communities with a direct interest in: nuclear facilities, nuclear projects, and nuclear technologies

- **Application Deadline:** July 3, 2026, at 11:59 p.m. EDT
- **Amount:**
 - Up to a maximum of \$100,000 per year for Indigenous Nations and communities
 - Up to a maximum of \$200,000 per year for Indigenous organizations representing multiple Indigenous Nations and communities

[Indigenous and Stakeholder Capacity Fund – Engagement and Collaboration Support](#):

Funding through the Engagement and Collaboration Support stream will be based on needs identified by Canadian Nuclear Safety Commission subject matter experts through ongoing engagement and collaboration activities with Indigenous Nations and communities, and stakeholders.

[Indigenous Intellectual Property Program Grant](#): This grant is a funding program designed to offer Indigenous Peoples additional support to understand and access Canada's Intellectual Property (IP) system. The grants fund eligible Indigenous organizations' initiatives and projects related to IP, and Indigenous knowledge and Indigenous cultural expressions. They can also fund participation in World Intellectual Property Organization (WIPO) sessions. The purpose of the grants is to: Explore ways to make the IP system more accessible to Indigenous Peoples; Facilitate and encourage Indigenous Peoples' strategic use of the IP system to protect their innovations and creations; Support Indigenous-led development of tools, guidelines or protocols with respect to the protection and use of IP and IP-related Indigenous knowledge and cultural expressions and; Increase participation of Indigenous Peoples in domestic and international discussions on IP, Indigenous knowledge and cultural expressions.

- **Amount:** \$150,000 per year

[Insight Grants](#): Insight Grants support research excellence in the social sciences and humanities. Funding is available to both emerging scholars and established scholars for research initiatives of two to five years.

- **Application Deadline:** October 1, 2026 (8:00 p.m. eastern)

- Stream A: \$10,000 to \$125,000 over 2 to 5 years
- Stream B: \$125,001 to \$500,000 over 2 to 5 years

[New Horizons for Senior Program – Community-based projects](#): This funding supports projects that are designed by seniors and for seniors in their communities. This program funds projects that empower seniors in their communities through increased social inclusion. Projects submitted for this grant must meet 1 of the program objectives: Promoting volunteering among seniors and other generations; Engaging seniors in the community through the mentoring of others; expanding awareness of elder abuse, including financial abuse; Supporting the social participation and inclusion of seniors; and Providing capital assistance for new and existing community projects and/or programs for seniors.

Capital assistance projects may use up to \$25,000 of the total approved funding, for eligible capital expenses.

- **Amount:** Up to \$50,000 for a project that is up to 1 year in duration

Previously identified funding opportunities:

[Building Communities Through Arts and Heritage Program - Legacy Fund Stream](#): This funding stream provides funding for community – initiative capital projects, intended for community use.

- **Application Deadline:** Projects must be submitted before the anniversary date of the event or personality to be commemorated.
- **Amount:** Recipients may receive up to 50 per cent of eligible project expenses up to a maximum of \$500,000.
- **Region:** Across Canada

[Building Communities Through Arts and Heritage Program – Local Festivals](#): This funding stream provides funding to local groups for recurring festivals that present the work of local artists, artisans, or heritage performers. This includes the celebration of LGBTQ2+ communities and Indigenous cultural celebrations.

- **Application Deadline:** January 31 – for festivals starting between September 1 and December 31 of the same calendar year; April 30 – for festivals starting between January 1 and June 30 of the next calendar year; and October 15 – for festivals starting between July 1 and August 31 of the next calendar year.
- **Amount:** Applicants may request up to 100 per cent of eligible expenses up to a maximum of \$200,000.

Canada Arts Presentation Fund – Professional Arts Festivals and Performing Arts Series

Presenters: This funding stream supports existing professional arts festivals and performing arts series presenters to offer activities that connect artists with their Canadian communities.

- **Application Deadline:** April 1st and October 15th for projects which will occur after April 1st of the following year - April 1st is the application deadline for projects starting between April 1st and June 30th of the following year.
- **Amount:** For Professional Arts Festivals, we can fund up to 25% of eligible expenses or a maximum of \$100,000 per fiscal year in the case of grants and 25% of eligible expenses or \$500,000 per year in the case of contributions.

Canada Cultural Spaces Fund (*FUNDING CHANGES*): As outlined in Budget 2025, the funding envelope of the Canada Cultural Spaces Fund (CCSF) will be reduced and reoriented over the next two fiscal years to focus solely on funding specialized equipment in the cultural sector. Projects for the renovation of an arts or heritage space with expenses that occur between April 1, 2026 and March 31, 2028 will be accepted while funds remain available. As of April 1, 2026, projects for completion of infrastructure planning and design documents, feasibility studies, and facility assessments are no longer accepted. Due to limited funding, construction projects are no longer accepted. However, exceptional circumstances may apply.

Cooperation with the Community Sector – Community Life: Supports engagement by community organizations and strengthens their ability to act while encouraging innovation and excellence. Eligible organizations must represent the interests of official-language minority communities. Their missions, mandates or the majority of their activities must support the development and enhancement of official-language minority communities nationally, provincially, regionally or locally.

- **Application Deadline:** Program funding deadline is September 20, 2026.
 - Project funding is a two-step process for some regions:
 - For national organizations as well as organizations located in Manitoba, Northwest Territories, Nunavut, Saskatchewan, and Quebec the funding application deadline is November 15, 2026.
 - For organizations located in Alberta, British Columbia, New Brunswick, Newfoundland and Labrador, Nova Scotia, Ontario, Prince Edward Island, a Letter of Intent is required to be sent by September 1, 2026 with the Funding application deadline following on November 15, 2026.

[Creating, Knowing and Sharing: The Arts and Cultures of First Nations, Inuit and Métis Peoples - Indigenous Organizations](#): The Indigenous Organizations component of *Creating, Knowing and Sharing* funds First Nations, Inuit and Métis organizations that engage in contemporary, customary or traditional artistic and cultural activities. These activities can include non-Indigenous artists and collaborations with non-Indigenous organizations. Grants support the exploration of innovative strategies for Indigenous creative and cultural expression, and related administrative activities.

- **Application Deadline:** Fall 2027
- **Amount:** Grant amount varies
- **Region:** Across Canada

[Creating, Knowing and Sharing: The Arts and Cultures of First Nations, Inuit and Métis Peoples – Small Scale Activities](#): Funds activities that will advance your artistic career or practice. This may include acquiring materials for artistic production, engaging in career or artistic development activities or benefitting from specific expertise, advice or training from a professional artist or cultural carrier. First Nations, Inuit and Métis individuals, artistic groups, collectives and organizations working in all disciplines can apply.

- **Application Deadline:** Any time before the start date of your project or activity
- **Amount:** Up to 5,000 per year
- **Region:** National

[Community Support, Multiculturalism, and Anti-Racism Initiatives Program – Events Component](#): This component provides funding to community-based events that promote intercultural or interfaith understanding, promote discussions multiculturalism, diversity, racism and religious discrimination, or celebrate a community's history and culture such as heritage months recognized by Parliament.

- **Application Deadline:**
 - 2025-26 events – applications must be received 18 weeks before the start date of the event.
 - For events starting between April 1 to July 31, 2026 – application intake period will take place from October 15 to November 26, 2025, at 4 PM ET.
 - For events starting between August 1 to November 30, 2026 – application intake period will take place from January 7 to February 18, 2026, at 4 PM ET.
 - For events starting between December 1, 2026 to March 31, 2027 – application intake period will take place from April 29 to June 10, 2026, at 4 PM ET.

[Endowment Incentives – Canada Cultural Investment Fund](#): Canada Cultural Investment Fund — Endowment Incentives component encourages private donors to contribute to endowment funds for not-for-profit professional arts organizations, so they can access new sources of funding in the future. Raising capital and creating endowments gives these

organizations greater capacity for realizing artistic expression by supporting their long-term stability. Canadians are encouraged to support the arts by providing donations to an arts organization's endowment fund. The government provides matching funds — of up to 1 dollar for every dollar raised from private donors — to create endowment funds or to increase existing ones.

[International Multisport Games for Aboriginal Peoples and Persons with a Disability – Hosting Program](#): The International Multisport Games for Aboriginal Peoples and Persons with a Disability (IMGAPPD) component of the Hosting Program provides competitive opportunities for designated, under-represented groups in Canada that face systemic barriers to sport participation. The IMGAPPD component provides contributions to organizations that are duly incorporated for the staging of the Games (known as Host Societies or Organizing Committees). Currently, the *Federal Policy for Hosting International Sport Events (2008)* stipulates that only the following four events are eligible for IMGAPPD component funding: The North American Indigenous Games, the Arctic Winter Games, the Special Olympics World Games and the Deaflympics.

[Museum Assistance Program – Exhibition Circulation Fund](#): **Notice: Due to a higher-than-normal volume of applications, funds for the Exhibition Circulation Fund are limited. We encourage applicants to speak to a regional program advisor prior to submitting an application.*

This funding opportunity assists museums with the costs related to the hosting of travelling exhibitions originating from another museum or from a federal heritage institution and the borrowing of artefacts from any of the National museums of Canada. Indigenous governing bodies or organizations with a mandate to preserve and support Indigenous heritage are eligible to apply.

[Promotion of Bilingual Services – Promotion of Linguistic Duality](#): encourages non-governmental organizations – particularly volunteer organizations – to provide services in English and French, and to share their best practices through innovative projects or initiatives. Priority is given to projects and initiatives that develop delivery models for bilingual services (action plan, policy development, pilot projects in organizations and businesses, feeder projects, mechanisms that can be exported to other organizations, etc.).

EMAP provides funding to First Nations communities so they can build resiliency, prepare for natural hazards and respond to them using the 4 pillars of emergency management.

[Regional Artificial Intelligence Initiative:](#) The Regional Artificial Intelligence Initiative (RAII) will provide support through two streams: **AI productization and commercialization** will help AI start-ups and growing firms scale up and address common challenges on their journey from lab prototypes to real-world applications, including securing growth capital, hiring the right people, managing data, and navigating regulatory frameworks; and **adoption of AI applications across critical sectors** will address the AI adoption lag among Canadian businesses and help enhance productivity, growth and competitiveness. Support will focus on addressing challenges faced by SMEs, such as skills gaps, AI integration complexities, and compliance with regulatory and industry standards.

[Worker Retention Grant for Work-Sharing Employers](#): The Worker Retention Grant (WRG) is designed to enable employers with an approved and implemented Work-Sharing agreement who commit to fostering training opportunities to provide additional income support to their Employment Insurance (EI) eligible employees who are working reduced hours and are on training. This Grant helps maintain employees' income by keeping their earnings closer to their normal wages throughout the duration of the Work-Sharing agreement.

COMMUNITY SAFETY

[Aboriginal Community Safety Planning Initiative](#): This initiative works to prevent incidents of Missing and Murdered Indigenous Women and Girls, provides to enhance accessibility to Restorative Justice Programming, and responds to the recommendations of the Truth and Reconciliation Commission.

[Canada Community Security Program \(CCSP\)](#): Public Safety Canada (PS) is working to build a safe and resilient Canada and has a renewed commitment to this goal through the Canada Community Security Program (CCSP). The CCSP provides time-limited funding and support for communities at risk of [hate-motivated incidents and hate-motivated crimes](#) to enhance physical security at their gathering spaces.

- **Amount:** CCSP will fund up to 70% of eligible costs to a maximum contribution of \$1.5 million per project, the remaining 30% of the project's cost are covered by the recipient.

ECONOMIC DEVELOPMENT

[Access to Business Opportunities](#): This funding offers non-repayable contributions, similar to grants. They fund national or regional projects that: promote a culture of entrepreneurship; improve access to business opportunities; and strengthen the capacity of other Indigenous businesses.

[Community Futures](#): The Community Futures program helps to create jobs in rural communities across Atlantic Canada. This is done through the work of over 40 [Community Business Development Corporations](#) (CBDCs) throughout Atlantic Canada.

You could get an interest-free contribution to cover up to 75% of the costs for: staff training; efficiency studies; marketing/trade activities; productivity improvements; quality assurance; environmental management systems.

[Clean Energy for Rural and Remote Communities Program](#): **Note: Given limited remaining funding, applications are being received only for the intent of maintaining a waiting list for consideration should funding become available.**

The Clean Energy for Rural and Remote Communities (CERRC) program provides funding for renewable energy and capacity building projects to reduce the reliance on fossil fuels for heating and electricity in Indigenous, rural and remote communities across Canada. In support of the clean energy transition, the program's objective is to reduce greenhouse gas emissions and fossil fuel use by increasing the use of local renewable energy sources and related energy efficiency measures.

This program provides approximately \$8 million per year in contribution funding to support Indigenous Peoples in the design, implementation or expansion of community-based climate monitoring projects. Specifically, the program supports Indigenous-led projects that monitor climate and the environmental effects of climate change within community boundaries and on traditional territories using Indigenous Knowledge Systems and western science.

The program objective is to reduce Northern communities' reliance on diesel for heating and electricity by increasing the use of local renewable energy sources and energy efficiency.

Projects that meet the criteria of the Community Infrastructure component are eligible for funding under the Economic Development budget envelope if the Community Infrastructure component has been entirely spent.

Entrepreneurship: must target business startup, expansion, or development. It must, in addition, meet one or more of the following requirements: have a structuring effect on the Indigenous population; target job creation for Indigenous people; be economically and socially sustainable; increase the visibility of the Indigenous nation or community and the Indigenous population in general; and enable the community's development objectives to be implemented; structuring projects for economic development that generate indirect benefits may also receive support, provided the benefits can be demonstrated.

- Note: Eligible costs for this category are limited to capital expenditure, as defined by generally accepted accounting principles. However, assistance may be granted for activities to promote transition to the digital age as part of an eligible entrepreneurial project. In this case, the costs linked to the design of websites or web platforms are eligible, for up to 20% of the total eligible project costs.

Study: A Study project must mainly concern the completion of a study needed to develop a project eligible for the economic development budget envelope. The project may, for example, concern: the completion of a business plan; an assessment of a project's technical and financial feasibility; a market analysis for an investment project, or a study for the integrated management of traditional Indigenous resources and activities.

- Note: The amount allocated to studies may not exceed 30% of the total budget envelope for economic development in the community.

Workforce Training: A Workforce Training project must mainly concern training and skills upgrading for the Indigenous workforce as part of an entrepreneurial project. The training needed for the startup, expansion or consolidation of an entrepreneurial project that is admissible for this program component may be eligible, provided that the person receiving the skills upgrading is Indigenous.

- Note: Funding for this type of training cannot exceed 20% of the total eligible project costs.

Assistance for local economic development: must mainly concern helping the nation or community to structure its economic development more effectively. More specifically, projects must aim to: help communities develop and coordinate a strategic economic development plan; identify, highlight and improve access to local resources; or recruit and train local economic development officers in Indigenous communities.

- Note: This financial assistance cannot exceed 50% of the economic development budget envelope allocated to the nation or community.

Social Economy Category: Social economy businesses sell products and services in innovative sectors that are just as diverse as those covered by other businesses. The mission of so-called "social economy" businesses is to sell goods and services that meet the needs of the community. They operate like a business but have a social purpose. Non-profit organizations whose mission is not mainly entrepreneurial, such as community organizations, charities, economic development corporations, municipal agencies, and so on, are not social

economy enterprises. However, these organizations can set up social economy projects that meet the criteria above, for example to generate own-source revenue. In addition, Indigenous non-profit organizations in Indigenous communities may also be eligible, provided that the goals of their social economy projects include generating own-source revenue.

- **Note:** The assistance granted by the Government of Québec and its agencies cannot exceed 80% of eligible costs, and the combined total of financial assistance received from various levels of government cannot exceed 95% of eligible costs.
- **Amount:** The per-project limit is set at \$200,000, and the maximum amount granted per organization is set at \$500,000 for the duration of the program. A single organization may implement several projects but may not exceed the maximum amount.

Women and Youth Category: supports projects whose objective is to promote entrepreneurship among Indigenous young people and women by offering financing possibilities in communities where other prospects are limited. Eligible projects must be connected to business startup or development. It is also possible for applicants to obtain funding for skills upgrading or training in connection with an entrepreneurial project. The funding must mainly concern the acquisition of the skills needed to complete an entrepreneurial project that is admissible for this program component, provided that the person receiving the skills upgrading is Indigenous. It is also possible to receive funding for activities to promote transition to the digital age as part of an eligible entrepreneurial project.

- **Note:** The per-project limit is set at \$150,000, and the maximum amount granted per promoter is set at \$250,000 for the duration of the program. The assistance granted by the Government of Québec and its agencies cannot exceed 70% of eligible costs, and the combined total of financial assistance received from various levels of government cannot exceed 95% of eligible costs.

Economic Mobilization Category: A project in this category must have a mobilizing effect on the overall economy of Indigenous communities. It must also be supported by a consensus among the Indigenous nations concerned. All necessary costs for implementing projects in this category are eligible.

- **Note:** The assistance granted by the Government of Québec and its agencies cannot exceed 50% of eligible costs, and the combined total of financial assistance received from various levels of government cannot exceed 95% of eligible costs.
